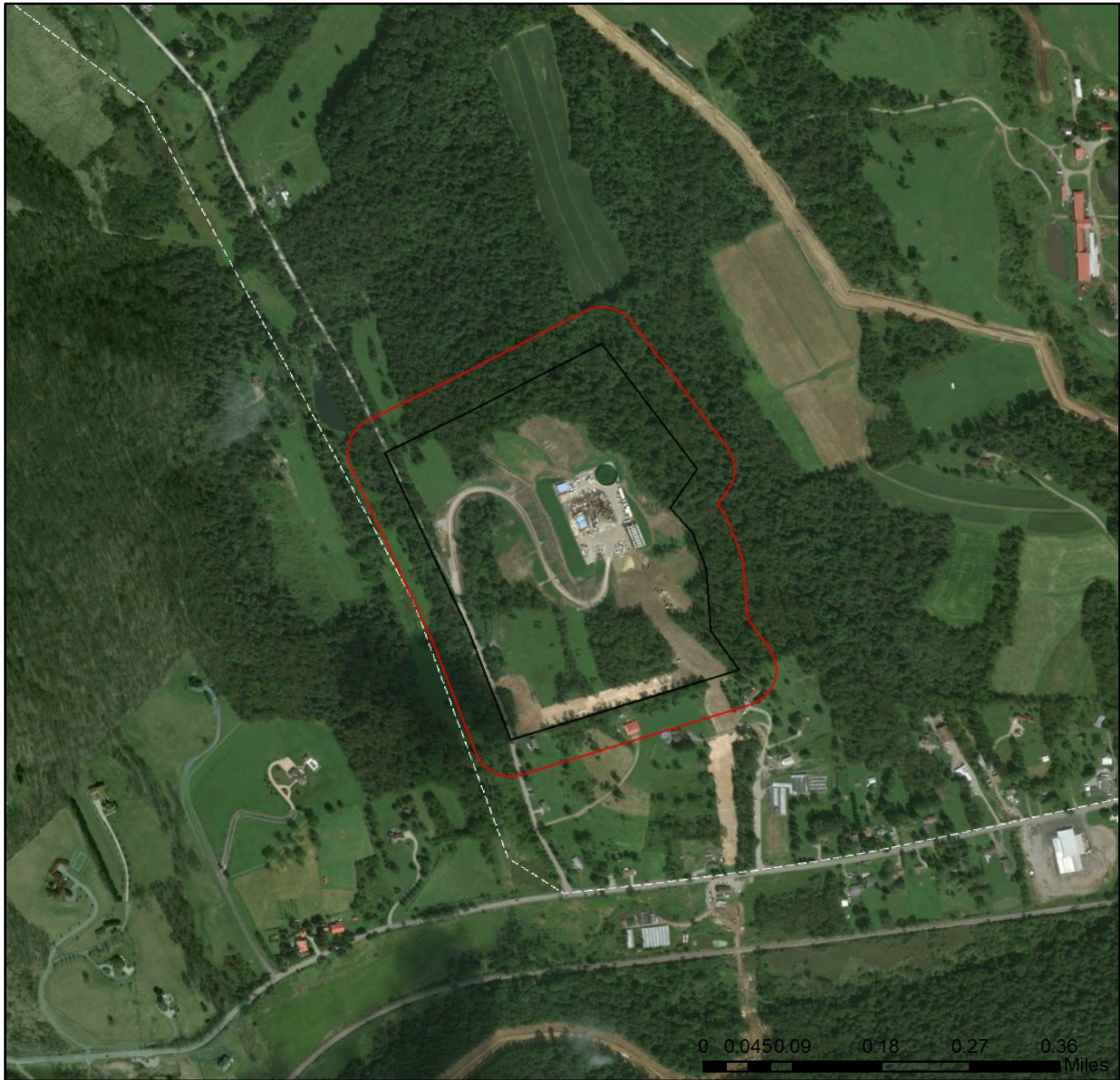

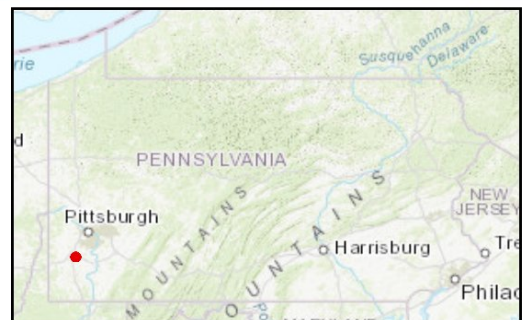

## Habanero Well Site

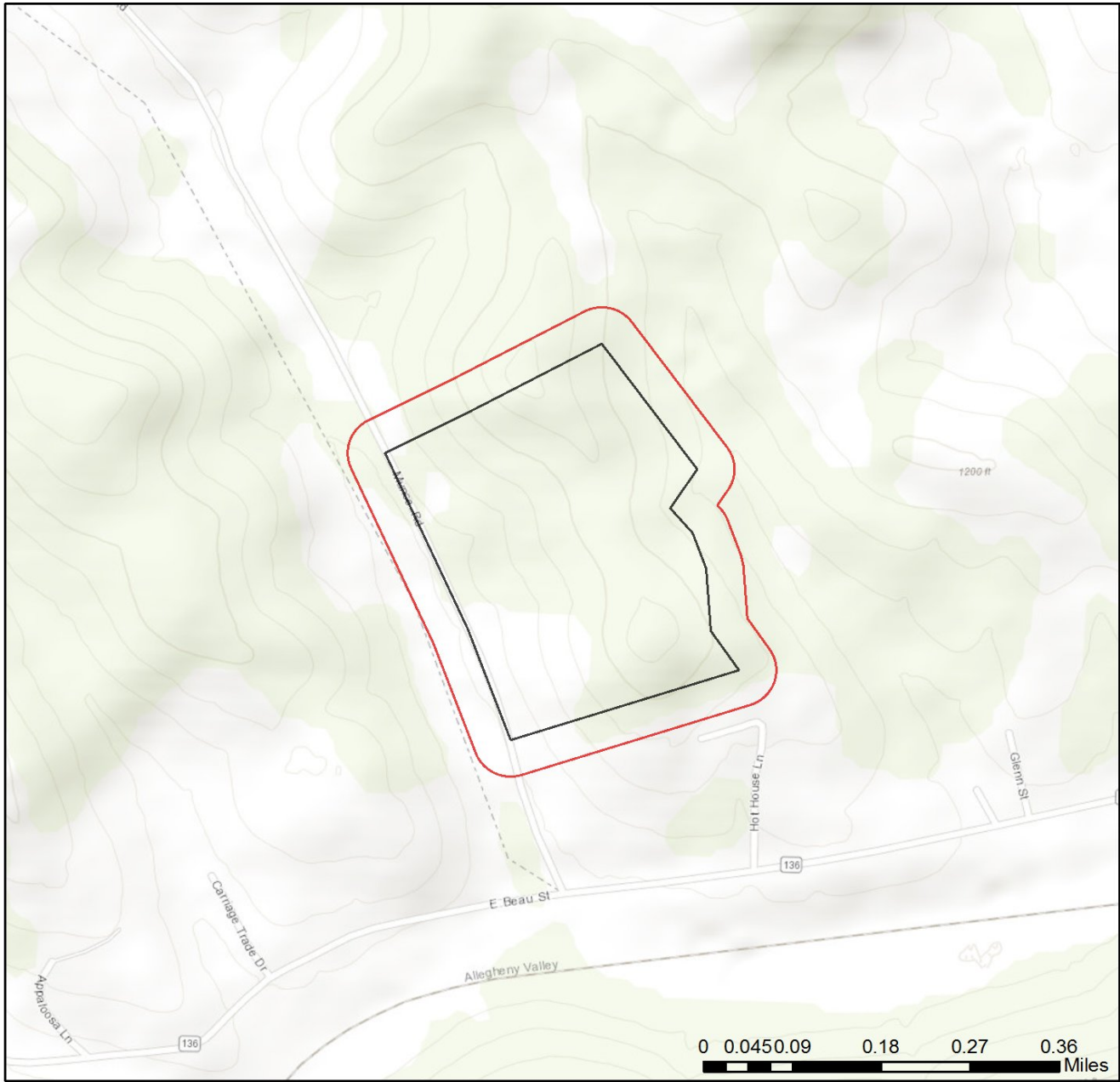


- Project Boundary
- Buffered Project Boundary



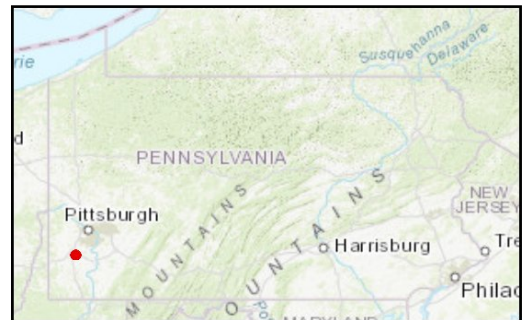

## 4. DEP INFORMATION
