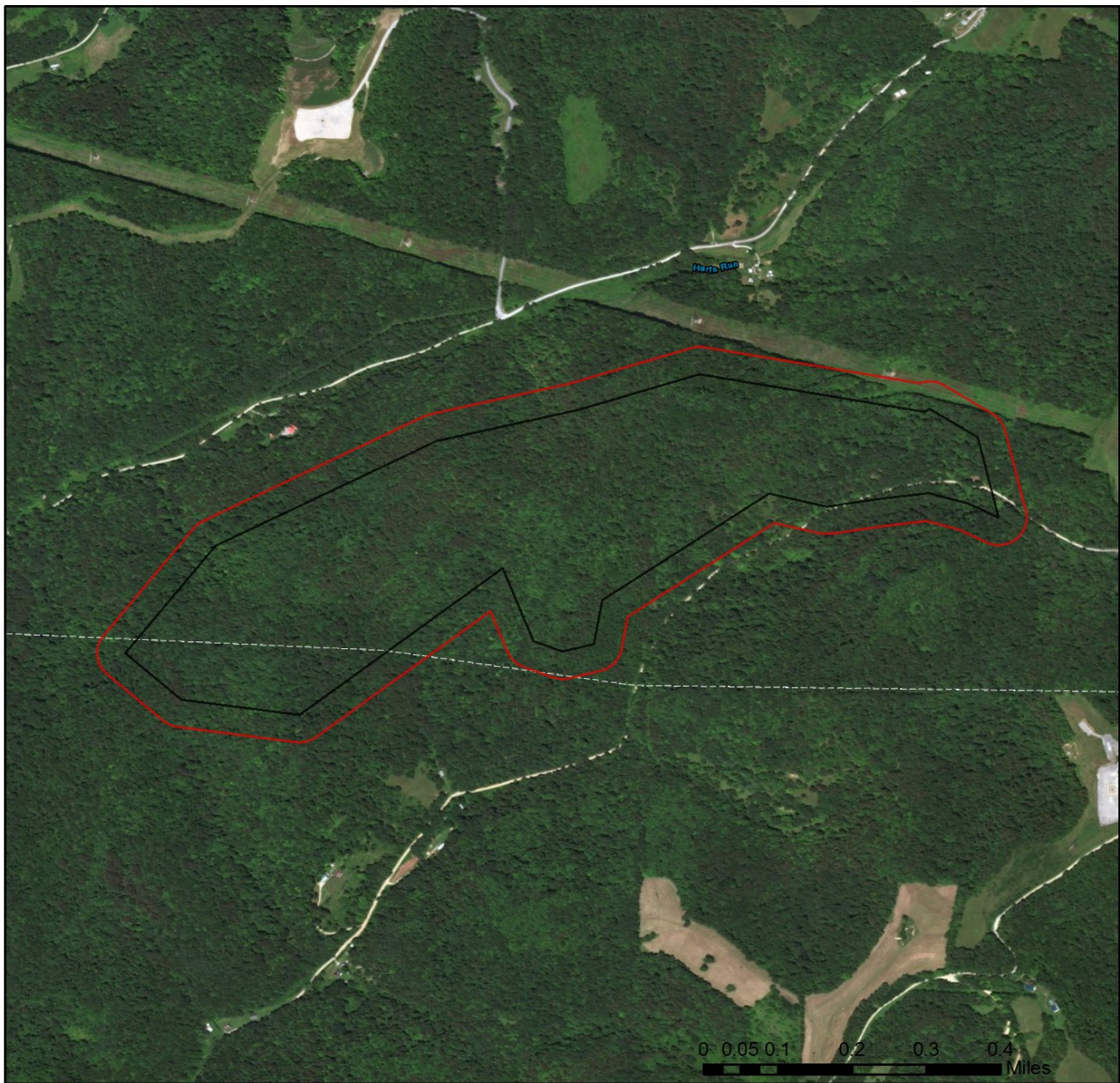

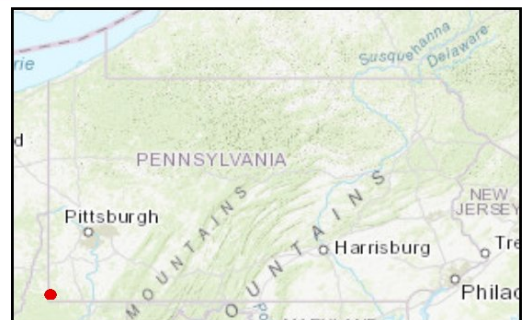

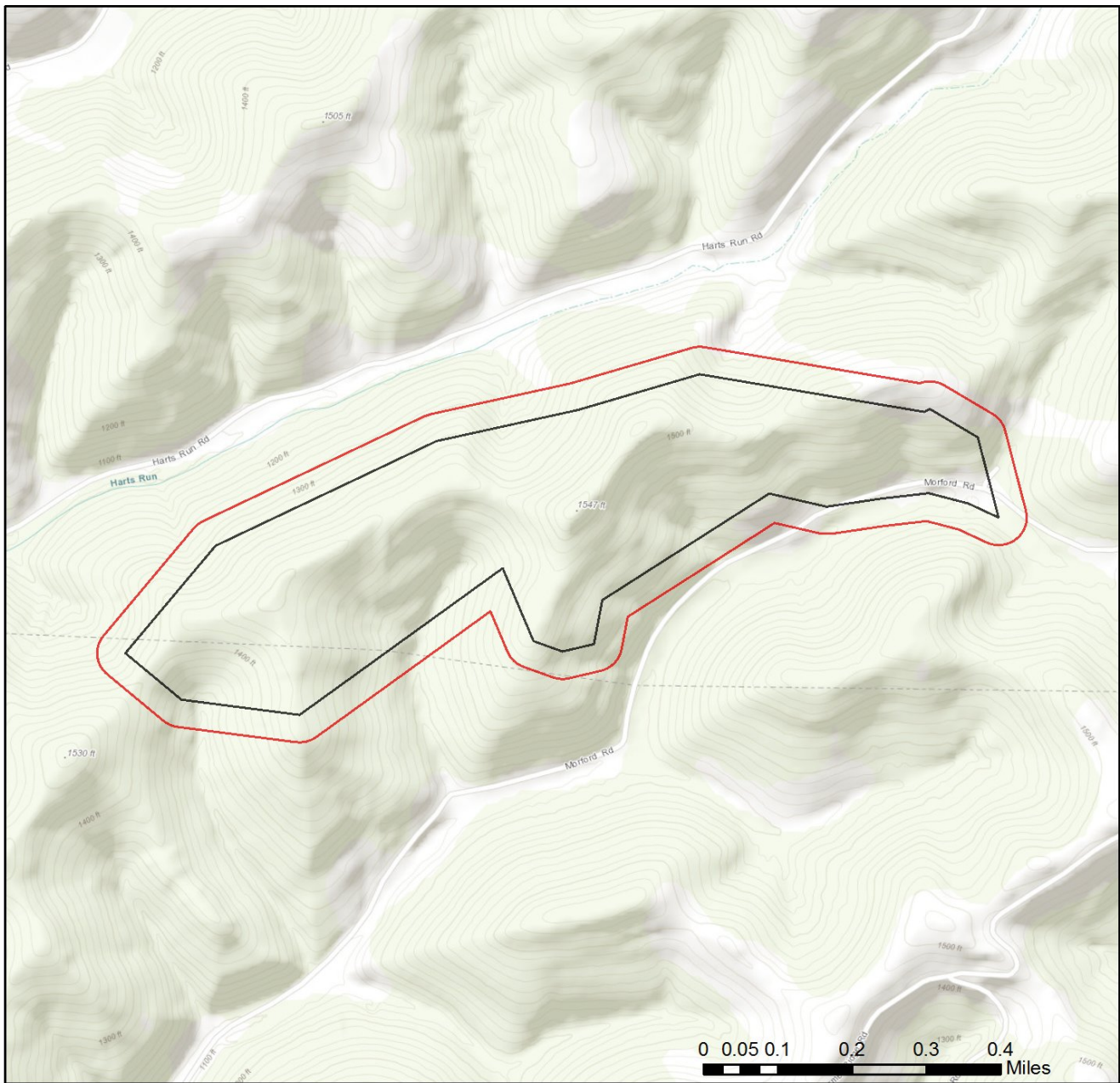


- Project Boundary
- Buffered Project Boundary

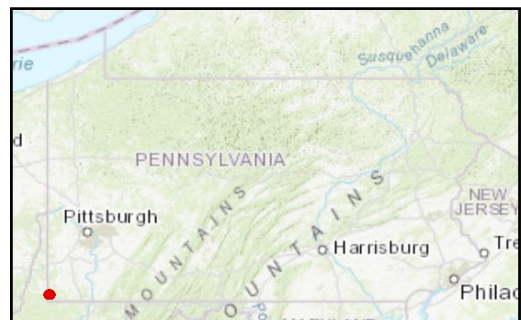

4. DEP INFORMATION

Thank you for the submission of the Pennsylvania Natural Diversity Inventory (PNDI) Environmental Review Receipt Number **651026 (Final_1)** for review (formerly PNDI Number 20141030472392). PA Department of Conservation and Natural Resources screened this project for potential impacts to species and resources under DCNR's responsibility, which includes plants, terrestrial invertebrates, natural communities, and geologic features only.

No Impact Anticipated (per concluded Mitigation and Monitoring)

Dieffenbach & Hritz, LLC (D&H) identified two locations of leaf-cup (*Smallanthus uvedalius*) within the proposed limits of disturbance (LOD) during a botanical survey conducted in the 2015 field season (see DCNR response letter dated July 2, 2015). D&H relocated the two leaf-cup populations to a southern aspect slope adjacent to the LOD.

The relocated population was visited by D&H on June 22, 2016 to document survivorship. Six individuals were observed and appeared to be in better condition than prior to relocation (see DCNR response letter dated July 14, 2016). Currently, the Piston Honda Well Site is being constructed. More light is being provided to the population due to tree clearance for the access road associated with the well site. No other indirect impacts appear to be affecting the population.

The leaf-cup population appears to be benefiting from the well site and access road construction. Therefore, DCNR has determined that no impact is likely. No further coordination with our agency is needed for this project.

This response represents the most up-to-date review of the PNDI data files and is valid for two (2) years only. If project plans change or more information on listed or proposed species becomes available, our determination may be reconsidered. Should the proposed work continue beyond the period covered by this letter, please resubmit the project to this agency as an "Update" (including an updated PNDI receipt, project narrative and accurate map). As a reminder, this finding applies to potential impacts under DCNR's jurisdiction only.
