In lieu of venting requirements of 78.92 or 78.93 relating to wells located in coal areas, EQT proposes to cement the well from total depth or attainable bottom to surface. This will meet the requirements of 78.91H regarding cementing solid from the total depth or approved attainable bottom to surface which is superior to a gel/cement sequence in coal area wells and eliminates the need for the vent.
