Olympus Energy, LLC would like to propose an alternative method to 25 PA Code 78a.83 (h) concerning the regulation depth of casing beneath an open mine. Olympus Energy will drill no more than 100' below bottom of the mined out Pittsburgh Coal Seam. Mine protection casing will then be set at least 30 feet (perhaps more than 50 feet if hole conditions dictate) below the base of the coal mine and cement to surface according to 25 PA Code Section 78a.83 (h). The reason for this request is to ensure that the casing shoe is able to reach a depth of 30' - 50' below the mine. We need to drill an additional 30' to capture the 15' - 20' of fill produced by the mine void. There are no gas zones known to exist within 100 feet below the mine. For any questions please contact:

Olympus Energy, LLC requests to avoid 25 PA Code 78a.85 (c) concerning the mandatory 8 hours waiting on cement time to continue operations. Olympus is making this request by proposing an alternate method to 78a.85(c) (3), in regards to slacking off the casing into the cement sheath. Olympus will secure the casing and not disturb the cement for each string under this alternative method (Surface, Coal/Mine, and Intermediate) by supporting the casing weight with the use of a casing hanger/landing ring wellhead system, which results in the cement no longer needing to devote early strength development to support the weight of the casing while curing. Olympus will pump the cement by the displacement method and utilize dual floats (1 in the shoe and 1 in the landing collar) to ensure the cement does not U-tube. In the event of loss returns during a mine cement job, which cement is not circulated to surface, Olympus will be able to utilize a grout string through the casing hanger system and perform a grout cement job bringing cement to the surface. With floats holding, the casing weight suspended on the dedicated hanger systems, and cement brought to surface, Olympus can therefore conduct operations safely and efficiently on surface during the 8 hour wait on cement time without compromising the integrity of the cement job. These operations would include handling/installing landing joints, risers, wellheads, & BOP's; function/pressure testing BOP's; installing packoffs; and picking up the next hole section's bottom hole assembly (BHA). Olympus will still be abiding by all details of regulation 78a.85 (b) in regards to cement standards and will not trip the new BHA into the well until at least 350 psi compressive strength is obtained at the zone of critical cement. Attached are the blend tests for all cement used in conjunction with this alternative method (surface/mine/coal strings will utilize the same cement slurry) in which the test temperature has been determined from offset log data and projected surface temperature.
