ORDER

NOW this 16<sup>th</sup> day of April, 2026, pursuant to Section 13(c) of the Coal and Gas Resource Coordination Act, Act of December 18, 1984, P.L. 1069, 58 P.S. §§ 501-518, the Department of Environmental Protection hereby authorizes Equitrans, LP (the "Applicant") to plug Well No. 2646 on the W.H. Orndoff farm, Center Township, Greene County, identified in the application attached hereto. Such plugging is to be conducted in accordance with the manner outlined in 25 Pa. Code §§ 78.91, 78.92 and 78.93 of the rules and regulations.

This authorization is conditioned on the Applicant's compliance with all applicable provisions of the Oil and Gas Act of 2012, 58 Pa. C.S. §§ 2301-3504; the Clean Streams Law, the Act of June 22, 1937, P.L. 1987, *as amended*, 35 P.S. §§ 691.1-691.1001; the Coal and Gas Resource Coordination Act, 58 P.S. §§ 501-518, and all other applicable laws.

Any person aggrieved by this action may appeal, pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. Section 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A, to the Environmental Hearing Board, Second Floor, Rachel Carson State Office Building, 400 Market Street, P.O. Box 8457, Harrisburg, PA 17105-8457, 717-787-3483. Appeals must be filed with the Environmental Hearing Board within 30 days of receipt of written notice of this action unless the appropriate statute provides a different time period. 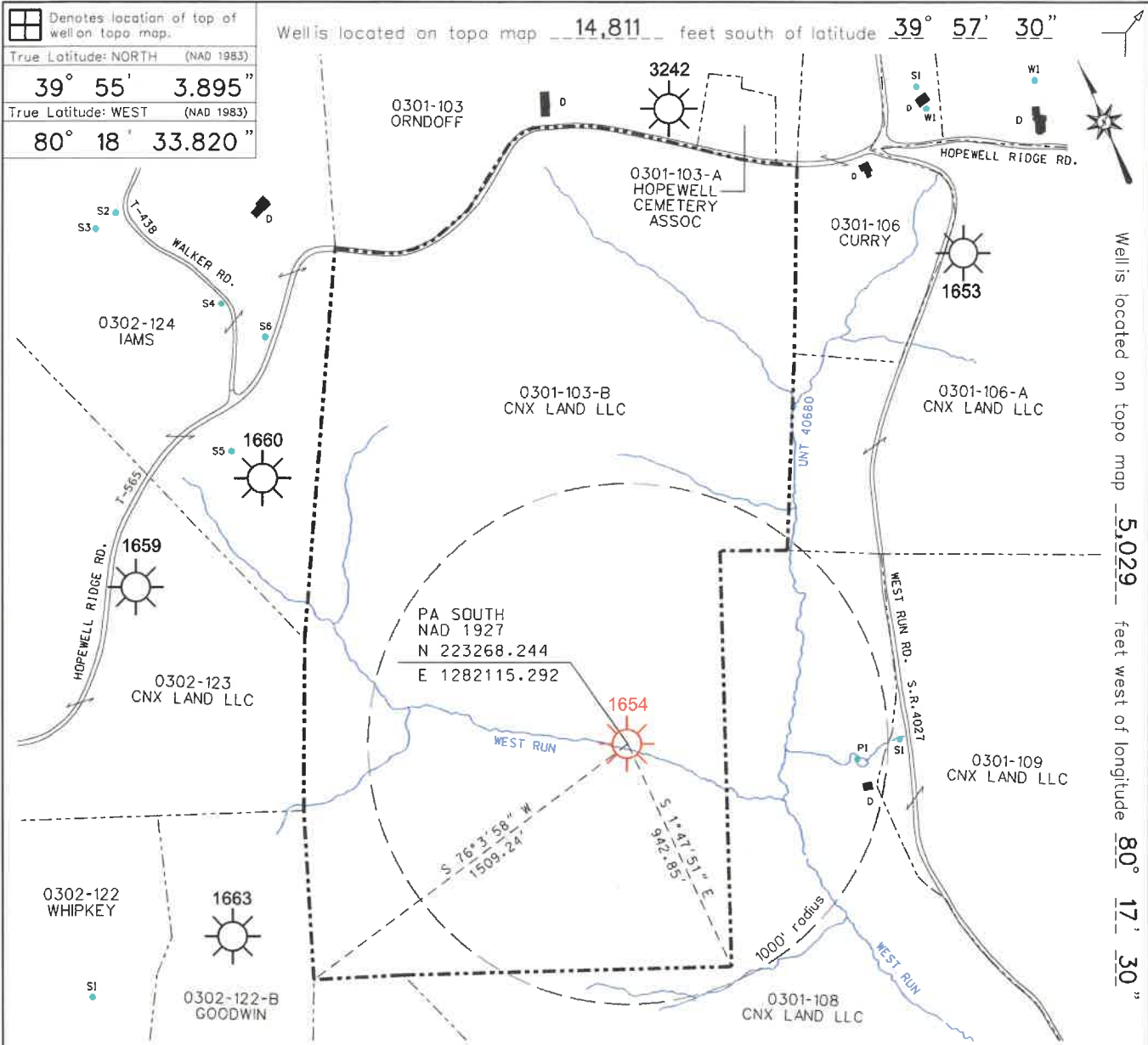

**DEED**

**THIS DEED (“Deed”)** is from **CONSOL PENNSYLVANIA COAL COMPANY LLC**, a Delaware limited liability company (“*Grantor*”), whose address is 1000 CONSOL Energy Drive, Canonsburg, PA 15317, to **CNX LAND LLC**, a Delaware limited liability company (“*Grantee*”), whose address is 1000 CONSOL Energy Drive, Canonsburg, Pennsylvania 15317, and is effective as of 8:00 a.m. (Eastern Daylight Time) on May **22**, 2015 (the “*Effective Time*”). GRANTOR and GRANTEE may be referred to herein individually as a “*Party*” and collectively as the “*Parties*.”

} **RECITALS**

**WHEREAS**, Grantor owns or operates coal mines in the area designated as the Subject Area on the map attached hereto as **Exhibit A-1** (the “*Subject Area*); and

**WHEREAS**, Grantee desires to receive from Grantor, and Grantor desires to grant and convey to Grantee, all right, title and interest in and to those certain surface interests held by the Grantor in the Subject Area, but only to the extent that such tracts are outside the Reserved Property. As used herein, “*Reserved Property*” means those surface tracts located within the cross-hatched portion of the Subject Area, as designated on the map attached hereto as **Exhibit A-2**, including, but not limited to, the tracts set forth on **Exhibit A-3** in their entirety. In the event of any discrepancy between the boundary reflected on the cross-hatched map on **Exhibit A-2** and the actual boundary of the tracts listed on **Exhibit A-3**, then the tracts listed on **Exhibit A-3** shall control.

**WHEREAS**, Grantor is willing to convey those limited surface rights only, excepting and reserving any and all rights to the Excluded Assets and associated rights so that Grantor may freely develop Grantor’s reserved interests without interference from the Grantee; and

**WHEREAS**, Grantee is willing to accept those rights conveyed hereunder, subject to those exceptions and reservations set forth herein.

**NOW, THEREFORE**, for and in consideration of the mutual promises contained herein, the benefits to be derived by each party hereunder, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Grantor and Grantee agree as follows:

**ARTICLE I  
DEFINED TERMS**

*Definitions.* Capitalized terms used herein shall have the meaning defined in Section 5 or throughout this Deed.

**ARTICLE II  
GRANT OF CONVEYED FEE INTERESTS**

**2.1 Conveyance.** Subject to the terms and conditions of this Deed, Grantor does hereby GRANT, CONVEY, and TRANSFER to Grantee, and Grantee agrees to acquire all of Grantor's right, title and interest in and to the surface interests held by Grantor in the Subject Area only insofar as those interests are outside of the Reserved Property, including but not limited to, those more particularly described on Exhibit B attached hereto and made a part hereof (such property and interests of Grantor, excluding the Excluded Assets, and subject to the Permitted Encumbrances, collectively referred to herein as the "*Conveyed Fee Interests*").

**2.2 Exception and Reservation of Excluded Assets.** The Conveyed Fee Interests shall not include, and Grantor hereby EXCEPTS and RESERVES to Grantor, its successors and assigns, the Excluded Assets and Grantor's interests in the Reserved Property.

**2.3 Third Party Consents.** Notwithstanding anything to the contrary provided in this Deed, to the extent that the conveyance of any portion of the Conveyed Fee Interests is prohibited by the terms of a deed, deed of trust, contract, agreement or other instrument, or would result in a breach or default by Grantor under any instrument, or the termination of Grantor's rights in or title to any portion of the Conveyed Fee Interests due to the conveyance of such Conveyed Fee Interests without the consent of a former grantor, deed of trust beneficiary, or other Person, then in such event the Conveyed Fee Interests shall not include, and shall exclude, such portion of the Conveyed Fee Interests as may be affected by such prohibition or requirement for such Person's consent unless and until such prohibition has been waived or all requisite consents have been obtained.

**ARTICLE III  
SPECIAL WARRANTY; SUBROGATION AND DISCLAIMERS**

**3.1 Special Warranty.** Grantor hereby binds itself, its successors and assigns, subject, however, to the Permitted Encumbrances, to warrant and forever defend all and singular title to the Conveyed Fee Interests for claims arising by, through or under Grantor, but not otherwise.

**3.2 Subrogation.** Grantor hereby assigns to Grantee all rights, claims, and causes of action under title warranties given or made by Grantor's predecessors in interest (other than any Affiliates of Grantor) with respect to the Conveyed Fee Interests, and Grantee is specifically subrogated to all rights which Grantor may have against such predecessors in interest with respect to the Conveyed Fee Interests, to the extent Grantor may legally transfer such rights and grant such subrogation.

**3.3 Disclaimers and Subrogation of Warranties and Representations.**

(a) EXCEPT AS AND TO THE LIMITED EXTENT EXPRESSLY SET FORTH IN SECTION 3.1 OF THIS DEED, AND WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, GRANTOR EXPRESSLY DISCLAIMS ANY REPRESENTATION OR WARRANTY, EXPRESS, STATUTORY, OR IMPLIED, BY GRANTOR OR ANY OF ITS AFFILIATES, AS TO (i) TITLE TO ANY OF THE CONVEYED FEE INTERESTS, AND (ii) THE MAINTENANCE, REPAIR, CONDITION, QUALITY, SUITABILITY, DESIGN, OR MARKETABILITY OF THE CONVEYED FEE INTERESTS. EXCEPT AS AND TO THE LIMITED EXTENT EXPRESSLY REPRESENTED OTHERWISE IN SECTION 3.1 OF THIS DEED, GRANTOR FURTHER DISCLAIMS ANY REPRESENTATION OR WARRANTY, EXPRESS, STATUTORY, OR IMPLIED, BY GRANTOR OR ANY OF ITS AFFILIATES, OF MERCHANTABILITY, FREEDOM FROM LATENT VICES OR DEFECTS, FITNESS FOR A PARTICULAR PURPOSE, OR CONFORMITY TO MODELS OR SAMPLES OF MATERIALS OF ANY CONVEYED FEE INTERESTS, IT BEING EXPRESSLY UNDERSTOOD AND AGREED BY GRANTOR AND GRANTEE THAT GRANTEE SHALL BE DEEMED TO BE OBTAINING THE CONVEYED FEE INTERESTS IN THEIR PRESENT STATUS, CONDITION, AND STATE OF REPAIR, "AS IS" AND "WHERE IS" WITH ALL FAULTS OR DEFECTS (KNOWN OR UNKNOWN, LATENT, DISCOVERABLE, OR UNDISCOVERABLE), AND THAT GRANTEE HAS MADE OR CAUSED TO BE MADE SUCH INSPECTIONS AS GRANTEE DEEMS APPROPRIATE.

(b) WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, NEITHER GRANTOR OR ITS AFFILIATES MAKES ANY REPRESENTATION OR WARRANTY REGARDING ANY MATTER OR CIRCUMSTANCE RELATING TO ENVIRONMENTAL LAWS, THE RELEASE OF MATERIALS INTO THE ENVIRONMENT, OR THE PROTECTION OF HUMAN HEALTH, SAFETY, NATURAL RESOURCES, OR THE ENVIRONMENT, OR ANY OTHER ENVIRONMENTAL CONDITION OF THE CONVEYED FEE INTERESTS, AND NOTHING IN THIS DEED OR OTHERWISE SHALL BE CONSTRUED AS SUCH A REPRESENTATION OR WARRANTY, AND GRANTEE SHALL BE DEEMED TO BE TAKING THE CONVEYED FEE INTERESTS "AS IS" AND "WHERE IS" WITH ALL FAULTS FOR PURPOSES OF THEIR ENVIRONMENTAL CONDITION AND THAT GRANTEE HAS MADE OR CAUSED TO BE MADE SUCH ENVIRONMENTAL INSPECTIONS AS GRANTEE DEEMS APPROPRIATE.

(c) GRANTOR AND GRANTEE AGREE THAT, TO THE EXTENT REQUIRED BY APPLICABLE LAW TO BE EFFECTIVE, THE DISCLAIMERS OF REPRESENTATIONS AND WARRANTIES CONTAINED IN THIS SECTION 3.3 ARE "CONSPICUOUS" DISCLAIMERS FOR THE PURPOSE OF ANY APPLICABLE LAW.

**ARTICLE IV  
ASSUMED OBLIGATIONS**

**4.1 Obligations Assumed by Grantee.** Grantee hereby accepts this Deed and expressly assumes and agrees to be bound by all terms and conditions of the Conveyed Fee Interests, and to be responsible for, and to fulfill, perform, pay and discharge (or cause to be fulfilled, performed, paid or discharged) all of the burdens, obligations, duties and liabilities assumed hereunder.

**ARTICLE V  
DEFINITIONS**

**5.1 Certain Definitions.** The following terms, as used herein, have the meanings set forth below:

**"Affiliate"** means, with respect to any Person, any other Person that directly or indirectly through one or more intermediaries, Controls or is Controlled by, or is under common Control with, such Person.

**"Control"** (including the terms **"Controlling," "Controlled by,"** and **"under common Control with"**) means the possession, direct or indirect, of the power to direct or cause the direction of the management and policies of a Person, whether through the ownership of voting shares, by contract, or otherwise.

**"Environmental Laws"** means all applicable federal, state and local Laws in effect as of the date of this Deed, including common law, relating to the protection of the public health, welfare and the environment, including those Laws relating to the storage, handling and use of chemicals and other Hazardous Substances and those relating to the generation, processing, treatment, storage, transportation, disposal or other management thereof. The term **"Environmental Laws"** does not include good or desirable operating practices or standards that may be employed or adopted by operators or recommended by a Governmental Authority.

**"Excluded Assets"** shall mean the following:

- (a) All right, title and interest in the Reserved Property; and
- (b) All coal, coal reserves and associated coal fee interests, together with all associated and appurtenant rights, privileges, benefits and powers conferred upon the holder of the coal with respect to the use and occupation of the surface, surface rights or property overlying the coal, including the right to subside; and
- (c) All rights, easements and privileges necessary, economical or useful in the mining, excavating, removing, exploring for, and producing by, any method whatsoever, of all of the coal and the rights and privileges to enter in, upon, over, under and through the Conveyed Fee Interests for the purpose of mining, excavating, removing, exploring for, and producing and shipping, by any method whatsoever, whether presently in existence

or developed in the future, including without limitation, longwall mining methods, and without being required to provide or leave support for the overlying stratas or surface, and without being liable in any way whatsoever for any claims for damages to the Conveyed Fee Interests caused by, or that occurs in connection with the operations of Grantor, its successors and assigns, on or off the Conveyed Fee Interests, including but not limited to, damage resulting to the overlying stratas or surface, or for damage or destruction to any water well, water line, or water course in or under the Conveyed Fee Interests, or for damage to any dwelling, building, shed, barn or other structure or improvement in or on the Conveyed Fee Interests, and without being required to restore the Conveyed Fee Interests to a condition capable of supporting pre-mining uses; the right to transport, haul, ship and market the coal on, over and across the Conveyed Fee Interests from this or other lands, and for the transportation of men and materials, without charge or wheelage obligations of any sort; the right to use the subterranean passageways and mine voids created by the mining and removal of the coal for the transportation and cross-haulage of coal or minerals produced from this or other lands, and for the transportation of men and materials, without charge or wheelage obligation of any sort; also the right to use the subterranean passageways and mine voids created by the mining and removal of the coal, and to use all such other underground spaces and passageways owned by Grantor, its successor and assigns, to pump, inject, drain, store and otherwise dispose of any product, whether in liquid, solid or gaseous form; the right to take and use such water, stone, clay, sand, gravel and slate from the Conveyed Fee Interests as may be reasonably required for use in connection with its mining operations; the right to take and use such non-merchantable timber from the Conveyed Fee Interests as may be reasonably required for use in its mining operations to the extent that it interferes with its mining operations; the right of perpetual access to the Conveyed Fee Interests for the purposes of designing and conducting such reclamation work as may be required by Law to obtain releases of the Conveyed Fee Interests from all mining and reclamation permits, and the right of perpetual access to the Conveyed Fee Interests, together with such easements over, across, upon, under and through the Conveyed Fee Interests as may be required or useful for the purpose of exercising all of Grantor's coal rights; the right to backfill, stow or otherwise fill the voids created by the mining of coal with any and all materials including, but not limited to, solid coal waste, gob, slurry, ash, scrubber sludge and other residue from the processing of coal and fly ash, bottom ash and other residue from the coal combustion process and other additives or waste materials all from any source (collectively, the "*Mining Rights*"), all without being liable for any injury or damage done thereby to the Conveyed Fee Interests or to anything therein or thereon, including water sources and structures, that may be caused by Mining Rights; and all rights and privileges retained herein are to be exercised without liability to

and without compensation to Grantee, its successors and assigns. Grantee, for itself, its successors and assigns, hereby waives and relinquishes all claims and demands for damages which it, its successors or assigns, may now have or may hereafter have under any Laws or under common law by reason of any such Mining Rights or other operations or other enterprise activity, including but not restricted to claims or demands for damages arising from noise, vibration, the pollution, diversion or obstruction of streams, wells or subterranean or surface waters, subsidence or slides of earth or refuse materials, the pollution of air or the emission of dust, smoke, fumes or noxious gases; and further Grantee hereby waives and releases all surface damages and damages of any sort howsoever caused, arising from the removal of and all operations in, said coal and said other coal by the Grantor, its successors or assigns, or arising from any and all physical conditions now present or which may hereafter develop in, about and/or above said coal seams or the horizons thereof and assumes all risk of loss to person or property resulting therefrom. It is understood and agreed that the rights hereinbefore mentioned are in enlargement and not in restriction of the rights incidental to the mineral estate and ownership of said coal; and

- (d) All wells, equipment, and mining and other facilities, including but not limited to those more particularly described in Exhibit C attached hereto and made a part hereof, and those facilities included on Grantor's mining permits, whether or not set forth on the Exhibits ("*Existing Facilities*"), as such Existing Facilities exist on the Effective Time, as well as all access rights in, upon, over, under, through or across the tracts on which said Existing Facilities are located, and including the right to construct, reconstruct, operate, test, inspect, replace, remove, alter, repair, maintain and use such Existing Facilities; and
- (e) All oil, gas, coalbed methane, coal mine methane, gob gas, occluded natural gas and other hydrocarbons (including condensate), or any combination thereof (collectively, "*Hydrocarbons*"), and any interest in or rights, including any reversionary rights, to such Hydrocarbons, together with all energy credits, associated and appurtenant rights, including but not limited to the right to use and occupation of the surface, surface rights or property overlying the oil and gas, and the right to bore through and in the Conveyed Fee Interests; and
- (f) Those particular properties (if any) as may be listed on Exhibit D, attached hereto and made a part hereof (the "*Excluded Properties*").

"*Governmental Authority*" means any federal, state, local, municipal, tribal, or other government; any governmental, regulatory, or administrative agency, commission, body, or other authority exercising or entitled to exercise any administrative, executive, judicial, legislative, belief, regulatory, or taxing authority or power; and any court or governmental tribunal, including any tribal authority having or asserting jurisdiction.

**"Hazardous Substances"** means any pollutants, contaminants, toxic, or hazardous or extremely hazardous substances, materials, wastes, constituents, compounds, or chemicals that are regulated by, or may form the basis of liability under, any Environmental Laws.

**"Law(s)"** means any applicable statute, law, rule, regulation, ordinance, order, code, ruling, writ, injunction, decree, or other official act of or by any Governmental Authority, including without limitation, the Pennsylvania Bituminous Mine Subsidence and Land Conservation Act, as amended, and any comparable state or federal law related to mine subsidence.

**"Lien"** means any interest in any of the Conveyed Fee Interests securing an obligation owed to, or a claim by, a Person other than the owner of such Conveyed Fee Interests, which is based on common law, statute or contract, and whether such claim or obligation is fixed or contingent, including but not limited to any lien, pledge, mortgage, deed of trust, security interest, attachment, judgment, right of first refusal, option, easement, right-of-way, restriction, servitude, permit, covenant, encroachment, condition, exception, reservation, claim, charge, defect or irregularity, encumbrance or any other adverse claim whatsoever.

**"Permitted Encumbrances"** means the following:

- (a) mechanics', carriers', workmen's, repairmen's or other like Liens arising or incurred in the ordinary course of business, in each case, in respect of obligations not yet due or delinquent, or if delinquent, being contested in good faith by appropriate actions;
- (b) Liens arising under equipment leases with third parties entered into in the ordinary course of business, in each case, in respect of obligations not yet due or delinquent;
- (c) any Liens, which do not, individually or in the aggregate, materially detract from the value of or materially interfere with the use or ownership of the Conveyed Fee Interests subject thereto or affected thereby (as currently used or owned);
- (d) Liens for ad valorem taxes, special or general assessments, personal property taxes, governmental charges or levies, and any related Liens, whether general or special, which are not delinquent as of the Effective Time or the amount or validity of which is being contested in good faith by appropriate proceedings;
- (e) zoning, occupancy, building, fire, health, environmental and pollution control laws, ordinances, rules and regulations and/or other land use Laws;
- (f) royalties and any overriding royalties, production payments, and other similar burdens on production that have been properly recorded in the applicable real property records as of the date hereof;

- (g) the rights of the owners of oil, gas and mineral interests and/or their lessees, if any, (i) to explore for, drill, produce and develop said oil, gas and minerals owned by them in, on, under and through the Conveyed Fee Interests, and (ii) to use as much of the Conveyed Fee Interests as necessary or convenient to explore for and extract said oil, gas and minerals;
- (h) all coal mining or surface use rights heretofore granted, or excepted or leased, that are apparent on an inspection of the Conveyed Fee Interests or recited in prior agreements, plans and instruments, whether or not recorded;
- (i) acts done or suffered to be done by, and Liens against, Grantee and those claiming by, through or under Grantee;
- (j) any matters that are waived in writing by Grantee;
- (k) restrictive covenants and defects, imperfections or irregularities of title, if any, as would not materially impair the use, ownership and/or operation of the Conveyed Fee Interests, burdened thereby in the manner currently used, owned and/or operated;
- (l) any rights of first refusal, reversionary interests, preferential rights, consents or similar options or restrictions that are either not triggered by the transactions contemplated by this Deed, have been obtained from the appropriate Person(s), have been waived in connection with the transactions contemplated by this Deed, which need not be satisfied prior to or are routinely obtained after the closing of this transaction, or for which the time for exercise has expired without exercise thereof; and
- (m) all contracts that pertain to the Conveyed Fee Interests and that will be binding on or beneficial to Grantee following the Effective Time, including but not limited to those contracts set forth on that Assignment, Assumption and Bill of Sale entered into between Grantor and Grantee and others of even date herewith.

*"Person"* means any individual, corporation, company, partnership, limited partnership, limited liability company, trust, estate, Governmental Authority, or any other entity.

#### ARTICLE VI MISCELLANEOUS

**6.1 Further Assurances.** Upon request by either party hereto, the parties agree to execute, acknowledge and deliver, or shall cause to be executed, acknowledged and delivered from time to time, no later than sixty (60) days after receipt of the request, such further instruments as are necessary to clarify the rights of either party to the Conveyed Fee Interests, the Reserved Property, or the Excluded Assets, including without limitation, any easement or

access rights for Existing Facilities and the rights of Grantor, its successors and assigns, to access and utilize any of the foregoing, and further including, but not limited to, executing, acknowledging and delivering (or causing to be executed, acknowledged and delivered), any instruments necessary for recording or filing with, and approval by, any applicable Governmental Authority.

**6.2 Covenants Running With the Land.** Grantor acknowledges and agrees that the terms of this Deed, including but not limited to, the Excluded Assets and the rights of Grantor hereunder, shall constitute a covenant running with the Conveyed Fee Interests.

**6.3 Successors and Assigns.** This Deed shall bind and inure to the benefit of the parties hereto and their respective successors and assigns.

**6.4 Separate Deeds.** Where separate deeds of the Conveyed Fee Interests have been or will be executed for filing in other recording jurisdictions or counties or for filing with, and approval by, applicable Governmental Authorities, any such separate deed (a) shall not constitute any additional grant of any of the Conveyed Fee Interests or interests in the properties covered hereby; (b) are not intended to modify, and shall not modify, any of the terms, covenants, and conditions or limitations on warranties set forth in this Deed and are not intended to create, and shall not create, any representations, warranties, or additional covenants of or by Grantor to Grantee; and (c) shall be deemed to contain all of the terms and provisions of this Deed, as fully and to all intents and purposes as though the same were set forth at length in such separate deeds.

**6.5 Severability.** If any section, paragraph or other part of this Agreement is determined by a court of competent jurisdiction to be illegal or otherwise unenforceable, such a determination shall not invalidate any other provisions of this Agreement.

**6.6 Exhibits.** The grantees named in **Exhibit B** to this Deed may be the historic party in the chain of title, and in some cases, said party may not be the current owner of the Conveyed Fee Interests. Grantor and Grantee may have listed on the Exhibits to this Deed the identification of the surface tax map and parcel numbers (if required for purposes of assigning a uniform parcel identifier or otherwise) which they believe are most closely associated with each of the Conveyed Fee Interests being conveyed hereunder. Grantor and Grantee have provided the surface tax map and parcel numbers listed on the Exhibits to this Deed for identification purposes only, and Grantor and Grantee only assert an ownership claim in and to those specific interests being conveyed by this Deed, the acreage of which may or may not correspond to the acreage reflected on the Exhibits.

**6.7 Governing Law; Jurisdiction; Venue; Jury Waiver.** THIS DEED AND MATTERS ARISING OUT OF OR RELATING TO THIS DEED SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE COMMONWEALTH OF PENNSYLVANIA, WITHOUT REGARD TO THE CONFLICT OF LAWS PROVISIONS THEREOF TO THE EXTENT SUCH PRINCIPLES OR RULES WOULD REQUIRE OR PERMIT THE APPLICATION OF THE LAWS OF ANY JURISDICTION OTHER THAN THOSE OF PENNSYLVANIA. EACH OF GRANTOR AND GRANTEE CONSENT TO THE EXERCISE OF JURISDICTION IN PERSONAM BY THE UNITED STATES FEDERAL DISTRICT COURTS LOCATED IN THE

COMMONWEALTH OF PENNSYLVANIA FOR ANY ACTION ARISING OUT OF THIS DEED OR ANY TRANSACTION CONTEMPLATED HEREBY. ALL ACTIONS OR PROCEEDINGS WITH RESPECT TO, ARISING DIRECTLY OR INDIRECTLY IN CONNECTION WITH, OUT OF, RELATED TO, OR FROM THIS DEED OR ANY TRANSACTION CONTEMPLATED HEREBY SHALL BE EXCLUSIVELY LITIGATED IN THE UNITED STATES FEDERAL DISTRICT COURTS HAVING SITES IN PITTSBURGH, PENNSYLVANIA (AND ALL APPELLATE COURTS HAVING JURISDICTION THEREOVER). EACH OF GRANTOR AND GRANTEE WAIVES, TO THE FULLEST EXTENT PERMITTED BY APPLICABLE LAW, ANY RIGHT IT MAY HAVE TO A TRIAL BY JURY IN RESPECT OF ANY ACTION, SUIT, OR PROCEEDING ARISING OUT OF OR RELATING TO THIS DEED OR ANY TRANSACTION CONTEMPLATED HEREBY.

**6.8 Counterparts.** This Deed may be executed in any number of counterparts, and each such counterpart hereof shall be deemed to be an original instrument, but all of such counterparts shall, when gathered together, constitute for all purposes one agreement. To facilitate recordation, there are omitted from the Exhibits to this Deed in certain counterparts descriptions of the Conveyed Fee Interests located in recording jurisdictions other than the jurisdiction in which the counterpart is to be filed or recorded.
