1. In lieu of venting requirements of 78.92 and 78.93 relating to wells located in coal areas, it is proposed to cement the well from TD or DEP-approved attainable bottom to surface.

2. Well shall be cemented using cement that meets or exceeds the ASTM International C 150, Type I, II or III Standard or API Specification 10 to stop the vertical flow of free gas or fluids.

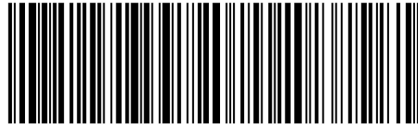
