The well bore will be cleaned out to total depth or DEP approved attainable depth. Removal of all free casing will be attempted. In lieu of the coal venting requirements set forth in the PA Code 25, section 78.92 a (3), a solid cement plug of expanding cement will be placed from total depth or DEP approved attainable bottom to the surface.

If it becomes necessary to deviate from this "Proposed Alternate Method" for that portion of the well bore 200 feet below the coal seam to be mined to the surface, approval must be received from the District Oil and Gas Inspector, or the Regional Oil and Gas Supervisor, or the Regional Compliance Manager, or the Regional Program Manager and the coal operator affected. A written record of this permission shall accompany the plugging certificate.

WELL LOCATION PLAT

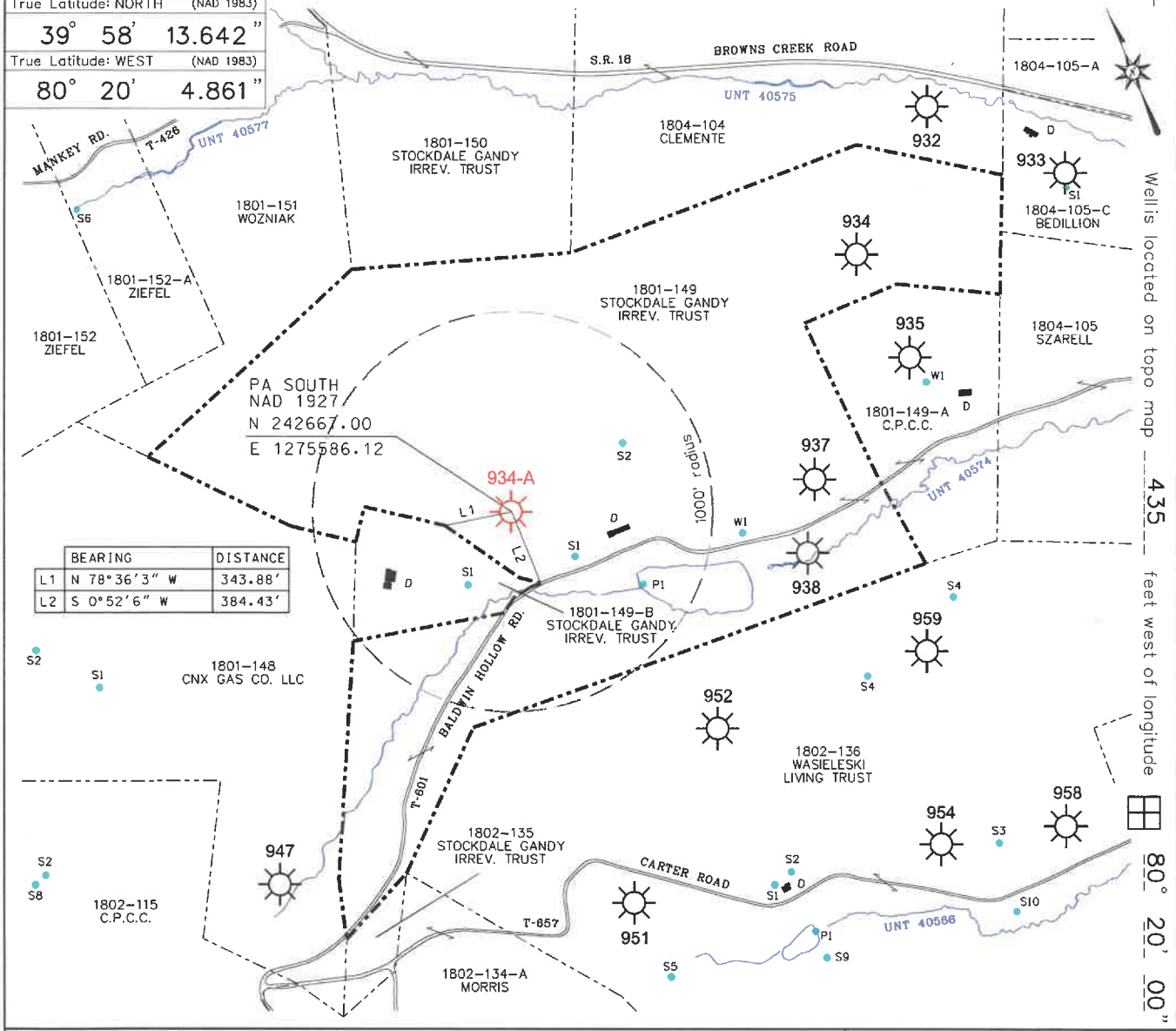
