ORDER

NOW this 27th day of April, 2026, pursuant to Section 13(c) of the Coal and Gas Resource Coordination Act, Act of December 18, 1984, P.L. 1069, 58 P.S. §§ 501-518, the Department of Environmental Protection hereby authorizes Leatherwood LLC (the "Applicant") to plug Well No. 2 on the Kenney farm, Morris Township, Greene County, identified in the application attached hereto. Such plugging is to be conducted in accordance with the manner outlined in 25 Pa. Code §§ 78.91, 78.92 and 78.93 of the rules and regulations.

This authorization is conditioned on the Applicant's compliance with all applicable provisions of the Oil and Gas Act of 2012, 58 Pa. C.S. §§ 2301-3504; the Clean Streams Law, the Act of June 22, 1937, P.L. 1987, *as amended*, 35 P.S. §§ 691.1-691.1001; the Coal and Gas Resource Coordination Act, 58 P.S. §§ 501-518, and all other applicable laws.

Any person aggrieved by this action may appeal, pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. Section 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A, to the Environmental Hearing Board, Second Floor, Rachel Carson State Office Building, 400 Market Street, P.O. Box 8457, Harrisburg, PA 17105-8457, 717-787-3483. TDD users may contact the Board through the Pennsylvania Relay Service, 800-654-5984. Appeals must be filed with the Environmental Hearing Board within 30 days of receipt of written notice of this action unless the appropriate statute provides a different time period. A Notice of Appeal form and the Board's rules of practice and procedure may be obtained online at www.ehb.pa.gov or by contacting the Secretary to the Board at 717-787-3483. The Notice of Appeal form and the Board's rules are also available in braille and on audiotape from the Secretary to the Board. This paragraph does not, in and of itself, create any right of appeal beyond that permitted by applicable statutes and decisional law.

This authorization does not purport to confer any rights of ownership or access, nor to confirm title in any person, nor to confer any rights for payment of any kind, to any other person or property owner.

IF YOU WANT TO CHALLENGE THIS ACTION, YOUR APPEAL MUST REACH THE BOARD WITHIN 30 DAYS. YOU DO NOT NEED A LAWYER TO FILE AN APPEAL WITH THE BOARD.

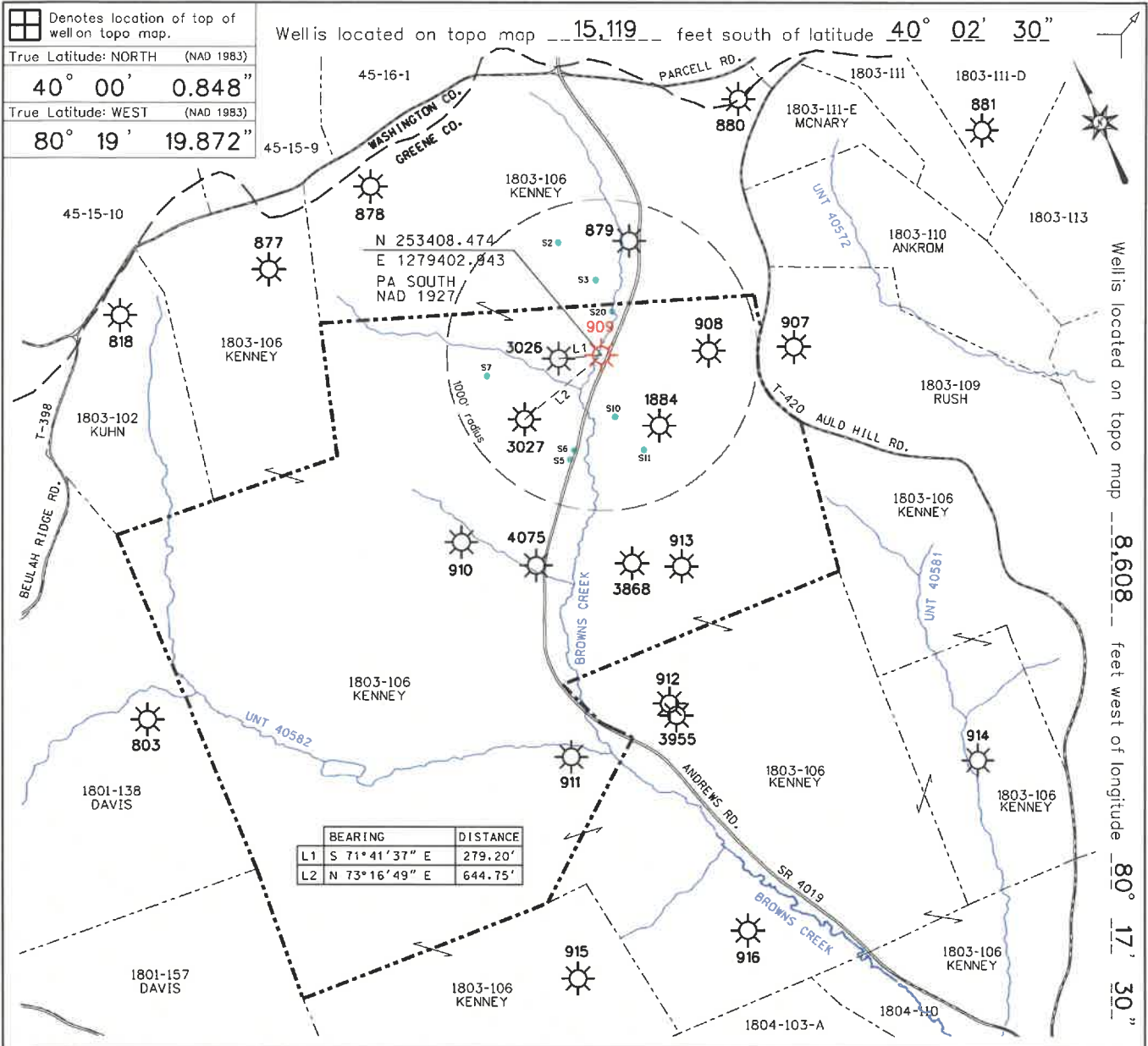

This Indenture, made the twenty sixth day of March in the year of our Lord one thousand nine hundred and two.

Between Charles H. Andrew and Madie E. Andrew of the Township

of Morris, County of Greene and State of Pennsylvania, parties of the first part, and George F. Auld of the Township, County and State aforesaid, party of the second part:

Witnesseth, that the said parties of the first part, for and in consideration of the sum of Five thousand six hundred seventy six and 12/100 (\$5676.12) lawful money of the United States of America unto them well and truly paid by the said party of the second part, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, aliened, conveyed, released, conveyed and confirmed and by these presents, do grant, bargain all their entire, release convey and confirm unto the said party of the second part, his

beirs and assigns, All the Coal of the Pittsburgh or River View in and under all that certain tract of land situate in the Townships of Morris, County of Greene and State of West Virginia, bounded and described as follows, to-wit:-

Andrew and Almira Bane, thence by lands of the said Almira Bane, South four degrees 14' West eight 1/2 furlongs to a Corner in Road; thence by the same South thirty eight degrees 13' West, with and eighty hundredths 112.50 furlongs to a Corner in Road; thence by the same South thirty one and three fourths degrees 12 3/4' West ten and seventy hundredths 110.70 furlongs to a Corner in Road; thence by the same South three and one fourth degrees 13 1/4' West nine and five hundredths 17.50 furlongs to a Point in the Road; thence by the same South eighteen and one half degrees 18 1/2' East seven and forty two hundredths 17.42 furlongs to a Point in Road; thence by the same South twenty nine degrees 17' East twelve and seventy hundredths 112.70 furlongs to a Corner in Road; thence by land of Geo. Putain South eighty nine degrees and twenty minutes 189° 20' West one hundred thirty two 1/2 furlongs to a Corner in Road; thence by the same South twenty two and one fourth degrees 122 1/4' East twenty and ninety hundredths 120.90 furlongs to a Corner in Road; thence by the same South forty degrees 140' East eighty nine 1/2 furlongs to a Corner in Road; thence by same South fifty four degrees 154' West seventy six and thirty hundredths 176.30 furlongs to a Stone; thence by same South eighty nine and one half degrees 189 1/2' West one hundred two and eighty hundredths 102.80 furlongs to a Stone; thence by lands of Conger and company and J. W. Day North two degrees 12' East two hundred two and fifty hundredths 1202.50 furlongs to a Stone; thence by lands of Lewis Hogue South eighty six and three fourth degrees 186 3/4' East Eighty nine and thirty hundredths 179.30 furlongs to a Stone; thence by the same North eighteen and one half degrees 18 1/2' East, forty nine and eight hundredths 149.80 furlongs to a Stone; thence by lands of J. Wiley Day, South twenty and one fourth degrees 170 1/4' East one hundred seventy one and thirty hundredths 171.30 furlongs to the place of Beginning,

Containing two hundred eighty three 1/2 (283 1/2) acres and one hundred thirty nine 1/2 (139 1/2) furlongs according to surveys made by R. J. McCharg, on the 14th day of Mar. A.D. 1700 and on the 25th day of Sept. A.D. 1711.

Together with free and uninterrupted right of way into,

upon and under said land at such points, and in such manner as may be proper and necessary for the purpose of digging, mining, colliery, ventilation, and surveying, away said coal, to: by mining and damages arising therefrom, or from the removal of all the said coal; together with the privilege of mining and removing through said described premises, the coal belonging to said party of the second part, his heirs and assigns; or which may hereafter be acquired.

Any surface land used by the said party of the second part, his heirs or assigns shall be paid for at the rate of one hundred fifty (\$150.00) dollars per acre.

Said parties reserve the right to drill through said coal for oil, coal gas and other minerals.

Together with all and singular the said property, improvements, ways, waters, water courses, rights, liberties, franchises, hereditaments and appurtenances whatsoever thereto belonging or in anywise appertaining, and the revenues and unincumbered rents, issues and profits thereof, and all the estate, right, title, interest, property, claim and demand whatsoever of the said parties of the first part in law, equity or otherwise howsoever, in and to the same and every part thereof.

To Have and to hold the said coal of the Pittsburg or River View and mining rights and privileges, with the reservations as aforesaid, hereditaments and premises hereby granted or mentioned and intended as to be, with the appurtenances unto the said party of the second part, his heirs and assigns to and for the only proper use and behoof of the said party of the second part his heirs and assigns forever.

And Charles H. Andrew and Madie E. Andrew his wife, the said parties of the first part, for themselves, their heirs, executors and administrators do by these presents, covenant grant and agree to and with the said party of the second part, his heirs and assigns, that they the said parties of the first part and their heirs all and singular the hereditaments and premises therein above described and granted or mentioned, and intended as to be, with the appurtenances, unto the said party of the second part his heirs and assigns, against their the said parties of the first part and their heirs, and against all and every other person or persons whatsoever lawfully claiming, or to claim the same or any part thereof, shall and will warrant and forever defend.

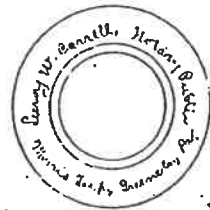
