EQT is requesting approval for the optional setting of additional CIBPs with placement downhole at Department approved locations outside of regulation 20ft intervals above oil, gas, and water bearing zones. These mechanical plugs in conjunction with Class A or Class L cement will help ensure all vertical gas flow in the wellbore is stopped.

EQT will communicate to DEP the intended setting depths of all CIBPs prior to placement. Should EQT be unable to place a CIBP in the intended location, EQT will inform the Oil and Gas Inspector. If EQT identifies the wellbore condition is not supportive of implementing this alternative method, EQT will inform the Oil and Gas Inspector and Oil and Gas Inspector Supervisor and will provide an email requesting to withdraw the alternative method.

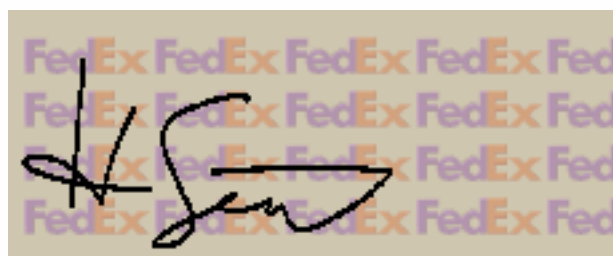
