This permit covering the well operator and well location shown above is evidence of permission granted to conduct activities in accordance with the Oil and Gas Act and the Oil and Gas Conservation Law, if the well is subject to that act and any rules and regulations promulgated thereunder, subject to the conditions contained herein and in accordance with the application submitted for this permit. This permit does not convey any property rights.

This permit and the permittee's authority to conduct the activities authorized by this permit are conditioned upon operator's compliance with applicable law and regulations.

Notification must be given to the district oil and gas inspector, the surface landowner and political subdivision of the date well drilling will begin at least 24 hours prior to commencement of drilling activities.

The permittee hereby authorizes and consents to allow, without delay, employees or agents of the Department to have access to and to inspect all areas upon presentation of appropriate credentials, without advance notice or a search warrant. This includes any property, facility, operation or activity governed by the Oil and Gas Act, the Oil and Gas Conservation Law, the Coal and Gas Resource Coordination Act and other statutes applicable to oil and gas activities administered by the Department. The authorization and consent shall include consent to the Department to collect samples of wastewaters or gases, to take photographs, to perform measurements, surveys, and other tests, to inspect any monitoring equipment, to inspect the methods of operation and disposal, and to inspect and copy documents required by the Department to be maintained. The authorization and consent includes consent to the Department to examine books, papers, and records pertinent to any matter under investigation pursuant to the Oil and Gas Act or pertinent to a determination of whether the operator is in compliance with the above referenced statutes. This condition in no way limits any other powers granted to the Department under the Oil and Gas Act and other statutes, rules and regulations applicable to these activities as administered by the Department.

This permit does not relieve the operator from the obligation to comply with the Clean Streams Law and all statutes, rules and regulations administered by the Department.

Special Permit Conditions:

1) This permit is conditioned upon the well operator obtaining all appropriate approvals, including local, municipal, and zoning approvals, and any revision or modification of those approvals.

2) Contact the Inspector at least 24 hours prior to commencing any frac/stimulation procedures.

This permit expires **07/20/2027** unless drilling is commenced on or before that date and prosecuted with due diligence.

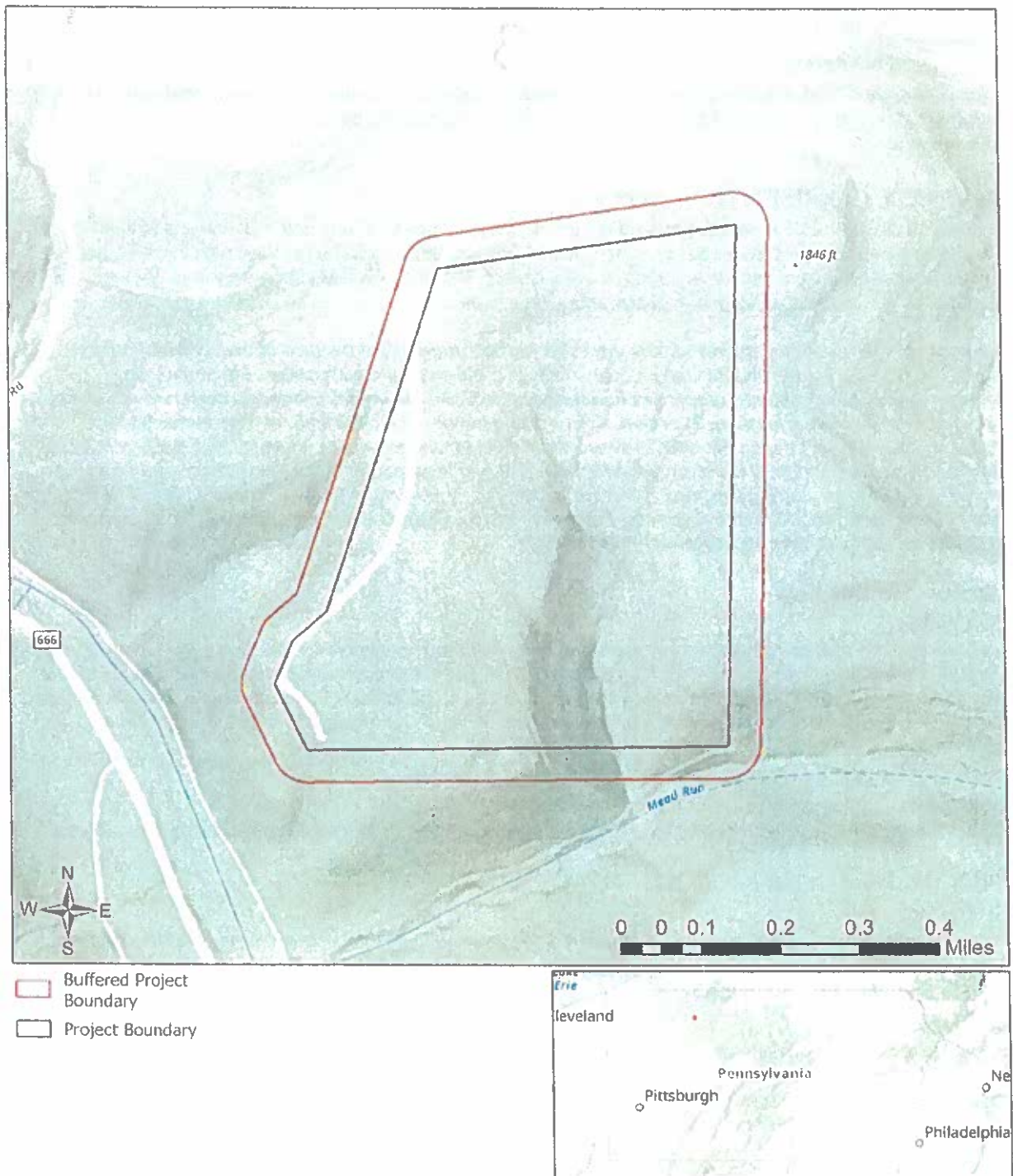

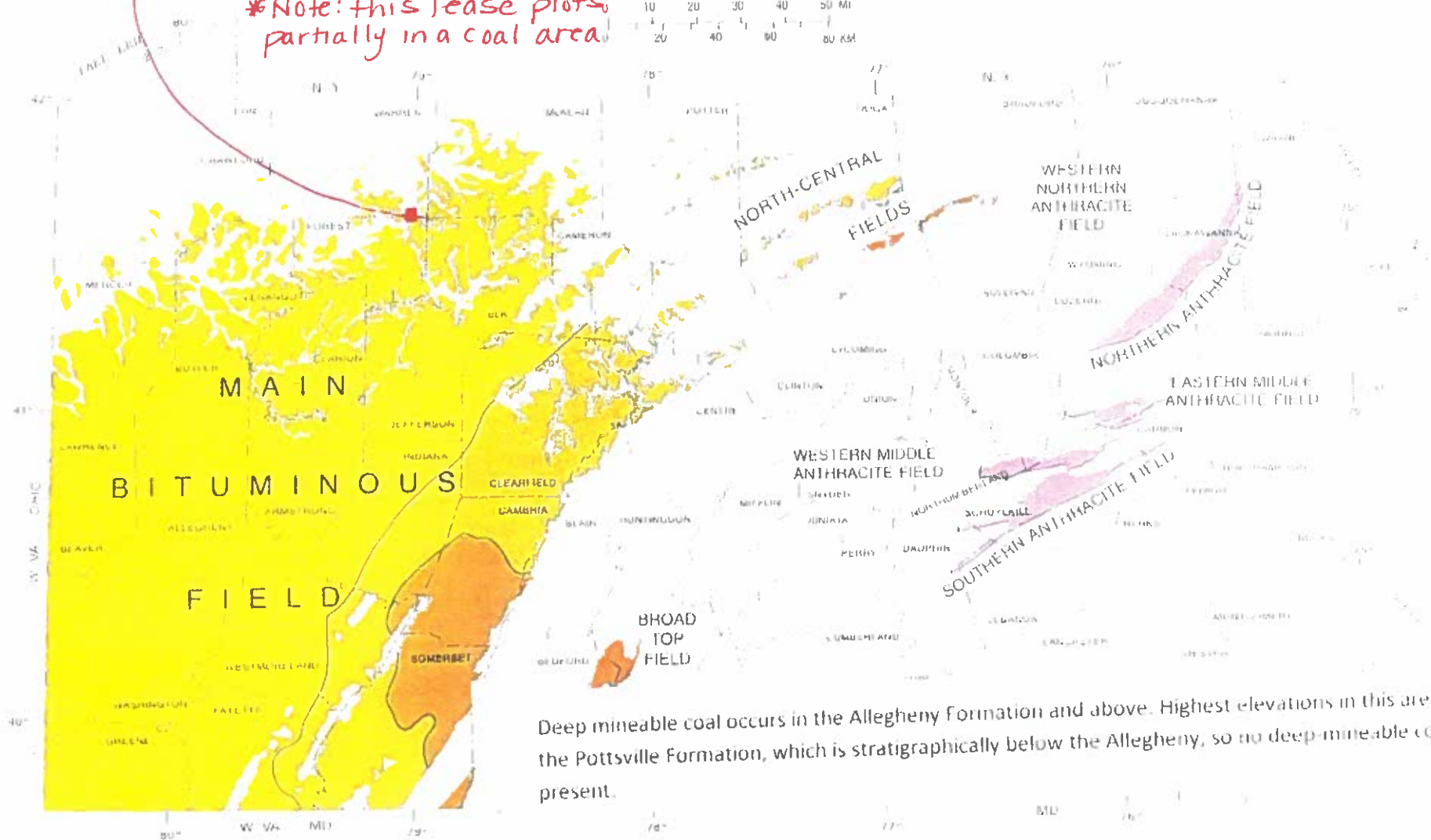

In response to your email, hopefully this will provide some clarification.

On page 1 of the permit application, a PNDI is required to be attached for completeness. That box should be checked because a PNDI is always required. A PNDI "hit" is any result on the PNDI search results other than no known impact. The additional directions, "any threatened or endangered "hit" must include a copy of the clearance letter from the applicable agency(ies)." is letting applicants know that this information will also be required if applicable.

On the coordination of a well location with public resources form, question 4, the key word is potential. Any PNDI search result other than no known impact is a potential conflict and this question would need to be answered. Agency contact information is given in section 6 of the PNDI form if you are looking for further information on the potentially impacted species.

In your answer to question 7 of the coordination of a well location with public resources form, it should be noted that a conservation measure was identified with the PA Game Commission, who deferred to the U.S. Fish and Wildlife Service and no potential impacts are anticipated. Please make this change and email me the updated coordination of a well location with public resources form.

I was reviewing some permit applications today before work and I came up with a few questions I was hoping you could answer on PNDI Searches.

1) On the permit application, page 1 it states "any threatened or endangered "hit" must include a copy of the clearance letter from the applicable agency."

The term "hit" here is not specific enough to tell whether that is considered a "potential impact" or a "conservation measure" based on the PNDI search results. I feel as if the permit application terminology should match the PNDI terms, if you are making them coincide with one another. If a conservation measure is found, should this box be checked or not checked on page 1 of the application?

2) On the coordination of a well location with public resources form, question #4 states "has the search of the proposed well location against the PNDI, or any other evaluation, identified a potential conflict with a species of special concerns?"

Same situation here, potential conflict (based on DEP form) and "potential impact, conservation measure" do not match, so how would this be answered on the coordination form? Technically a conservation measure, which requires no further documentation to the applicable agency is not considered a conflict. Does that mean that the coordination form, with a conservation measure, does not need to be filled out for the additional questions to #4? My PNDI doesn't even state what animal is being impacted.

Please let me know how to proceed with answering these questions so that everything is covered properly.

Thank you for taking the time to review the Pennhills permits Wt. 1072, wells 2-4. I prepared the permit applications so I can answer your questions accordingly, on behalf of Pennhills.

Deficiency #1 - In years past I have submitted permit applications that are not located within a EV or HQ watershed with this left blank. The permits got bumped back because the reviewer didn't know what watershed the wells were located in, and insisted we fill that area out even if it did not apply to the actual question. Every permit submitted since, with the same situation, has gone unquestioned. If you feel the need that this should be omitted, please update accordingly on your end, you have my consent. I will need to know going forward how this should be done.

Deficiency #2 - the PNDI as submitted is correct and valid. The trees in this area were recently harvested by the landowner and therefore no trees will be affected as part of this project. I feel as if the answered questions on the PNDI, the signature on the PNDI and the signed permit application should be a valid form of consent to this and it should not be questioned.

Deficiency #3 - The non-coal justification that we have is a very thorough and detailed amount of information, all proving that there is no coal here. The documents we have for old well logs are of an age and quality that are not 100% clear, but that is what we have and that is how they prepared them at the time. The copies that we have, and that were supplied may not be large, but in our file they are definitely legible. For ease of your review, I have copied the non-coal justification sheet and increased its size on my copier to make it larger for you to see. To aid in the review of the drillers logs our geologist typed a summary at the top left corner that we thought would make the review even easier and faster.

Thank you for your thorough review of these applications. My goal going forward is to have no deficiencies in hopes that your job and mine both become easier. The deficiencies you have outlined will be the same on all our permit applications because everything on them has been done and approved in the past and is all valid. The answers on the future applications will all be the same.

Review of the Pennhills Resources, LLC WT 1072 Wells (2-4) drilling permit applications yields the following deficiencies:

Application

- Question number 7 on the application: the well site is not in an EV or HQ watershed. Mead Run should be omitted from the answer.

PNDI Form

- In section 2 of under response to question(s) asked, your response to question 1 indicates there will be no disturbance to trees such as tree cutting (or other means of knocking down, or bringing down trees, tree topping, or tree trimming), pesticide/herbicide application, or prescribed fire. Upon review, the well sites are in a forested area with proposed access roads marked on the plat. If a change to question 1 results in a change to the outcome of the PNDI, then the coordination of a well location with public resources form will need to be updated.

Non-Coal Justification

- Because the wells are located within a coal area, it must be determined that the coal is not workable coal to classify the wells as non-coal. The supporting documentation included for why the wells should be considered non-coal is too small to be legible. Please format so that each well log and justification are on a separate page for further review.

Please provide the corrections for these deficiencies via e-mail by June 30, 2026 so the review may continue.
