This permit covering the well operator and well location shown above is evidence of permission granted to conduct activities in accordance with the Oil and Gas Act and the Oil and Gas Conservation Law, if the well is subject to that act and any rules and regulations promulgated thereunder, subject to the conditions contained herein and in accordance with the application submitted for this permit. This permit does not convey any property rights.

This permit and the permittee's authority to conduct the activities authorized by this permit are conditioned upon operator's compliance with applicable law and regulations.

Notification must be given to the district oil and gas inspector, the surface landowner and political subdivision of the date well drilling will begin at least 24 hours prior to commencement of drilling activities.

The permittee hereby authorizes and consents to allow, without delay, employees or agents of the Department to have access to and to inspect all areas upon presentation of appropriate credentials, without advance notice or a search warrant. This includes any property, facility, operation or activity governed by the Oil and Gas Act, the Oil and Gas Conservation Law, the Coal and Gas Resource Coordination Act and other statutes applicable to oil and gas activities administered by the Department. The authorization and consent shall include consent to the Department to collect samples of wastewaters or gases, to take photographs, to perform measurements, surveys, and other tests, to inspect any monitoring equipment, to inspect the methods of operation and disposal, and to inspect and copy documents required by the Department to be maintained. The authorization and consent includes consent to the Department to examine books, papers, and records pertinent to any matter under investigation pursuant to the Oil and Gas Act or pertinent to a determination of whether the operator is in compliance with the above referenced statutes. This condition in no way limits any other powers granted to the Department under the Oil and Gas Act and other statutes, rules and regulations applicable to these activities as administered by the Department.

This permit does not relieve the operator from the obligation to comply with the Clean Streams Law and all statutes, rules and regulations administered by the Department.

Special Permit Conditions:

- 1) This permit is conditioned upon the well operator obtaining all appropriate approvals, including local, municipal, and zoning approvals, and any revision or modification of those approvals.
- 2) Contact the Inspector at least 24 hours prior to commencing any frac/stimulation procedures.
- 3) To avoid impacts to Swainson's Thrush during the breeding and nesting seasons, all site preparation, construction, and restoration activities within the proposed project area should occur from August 16th through May 14th. Work in this area should avoid the period from May 15th to August 15th.

The Operator shall comply with the following:

1. Notify their local Oil and Gas Inspector three days prior to dusting.
2. Drill cuttings shall remain on the well site they are generated and shall not be dispersed off-site via air, surface water, or groundwater.
3. All isolation distances identified in 25 Pa. Code § 78.60 – 78.63 are applicable.
4. Drill cuttings may be disposed of in a pit, without contact with season high ground water.
5. Upon well completion, the pit shall be backfilled and graded to promote runoff. The stability of the backfilled pit shall be compatible with surrounding area and the pit area shall be revegetated to stabilize surface soil.
6. Land application may only occur on the cleared well pad area and the drill cuttings shall be spread and incorporated to a depth of at least 6 inches and revegetated to stabilize surface soil.
7. No land application shall occur if the ground is frozen or saturated.

This permit expires **07/27/2027** unless drilling is commenced on or before that date and prosecuted with due diligence.

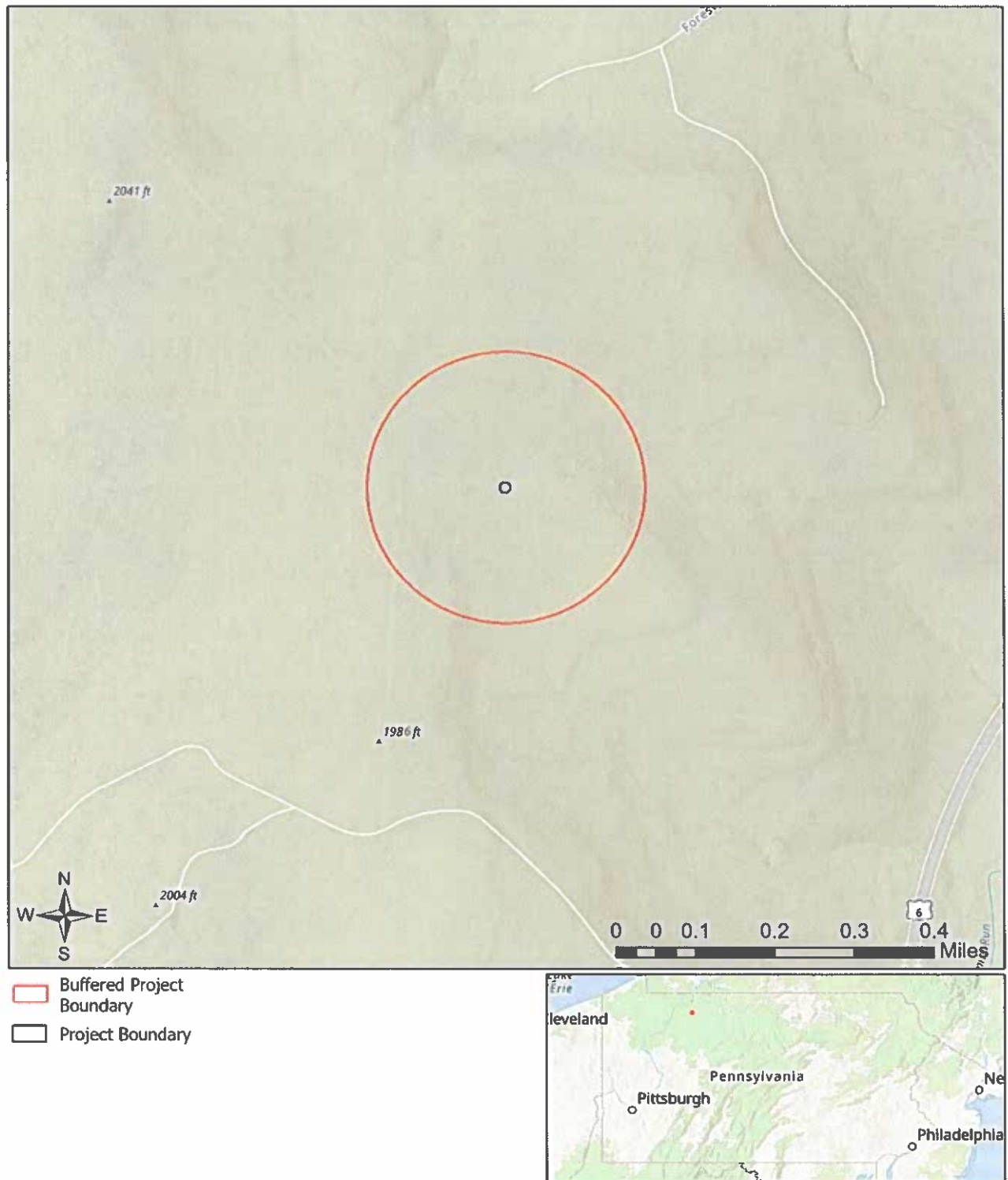

The Proposed Oil Well will be the drilling of a new well located as represented on the well location plat which is also provided with this narrative. The anticipated total depth of the proposed well will be 2000' and will target the Cooper sand. The total disturbed acreage for the project will not exceed five acres.

This project will consist of the construction of a 75' x 100' well pad around the well location with appropriate access roads from existing roads. In addition, a 20,000 gallon freshwater impoundment will be constructed on well pad for use in fracking the proposed well. Prior to construction all necessary BMP's will be installed and will remain until the site is reclaimed. All remaining disturbed areas will be prepared for vegetative stabilization. When all disturbed areas reach a uniform 70% perennial re-vegetation, the straw bale barriers, filter fence and any other temporary BMP's will be removed. Any excess soils and any waste material will be disposed of in an environmentally sound manner.

Current site condition consists of deforested ground. No wetlands exist within the proposed project boundary and no wetlands will be disturbed during construction of the project.

Any recommendations from PNDI affected parties (PGC, PA DCNR, PFBC, USFWS, etc.) will be adhered to in best practices practical manner.

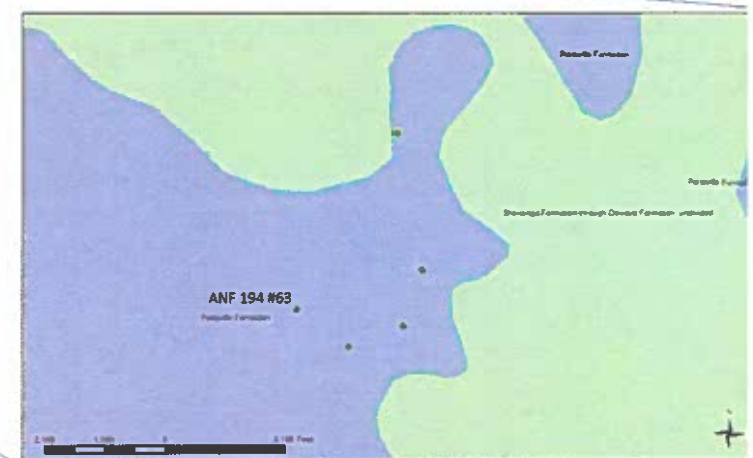
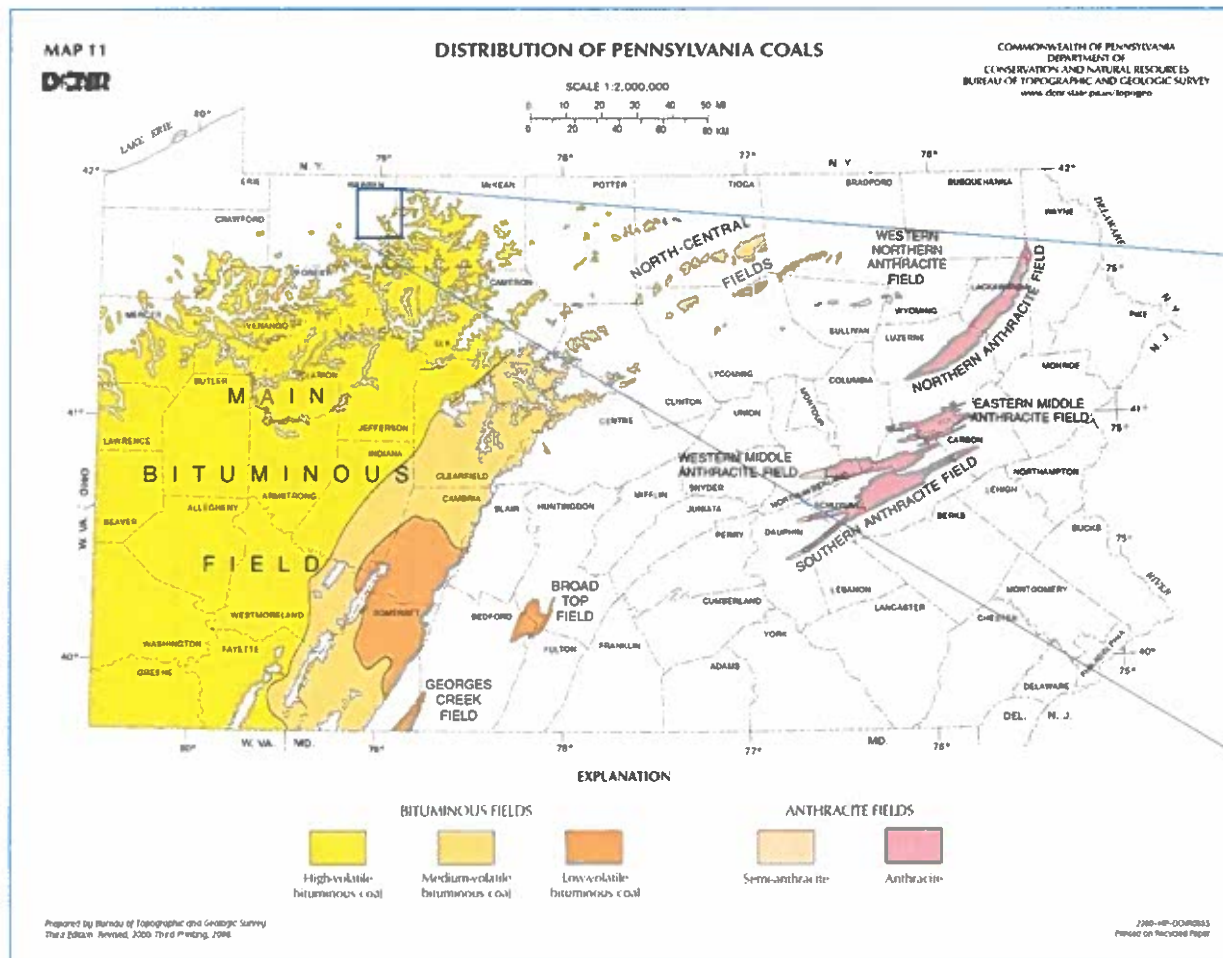

Additionally, past area well development in the vicinity supports non-coal designation based on well drilling logs.



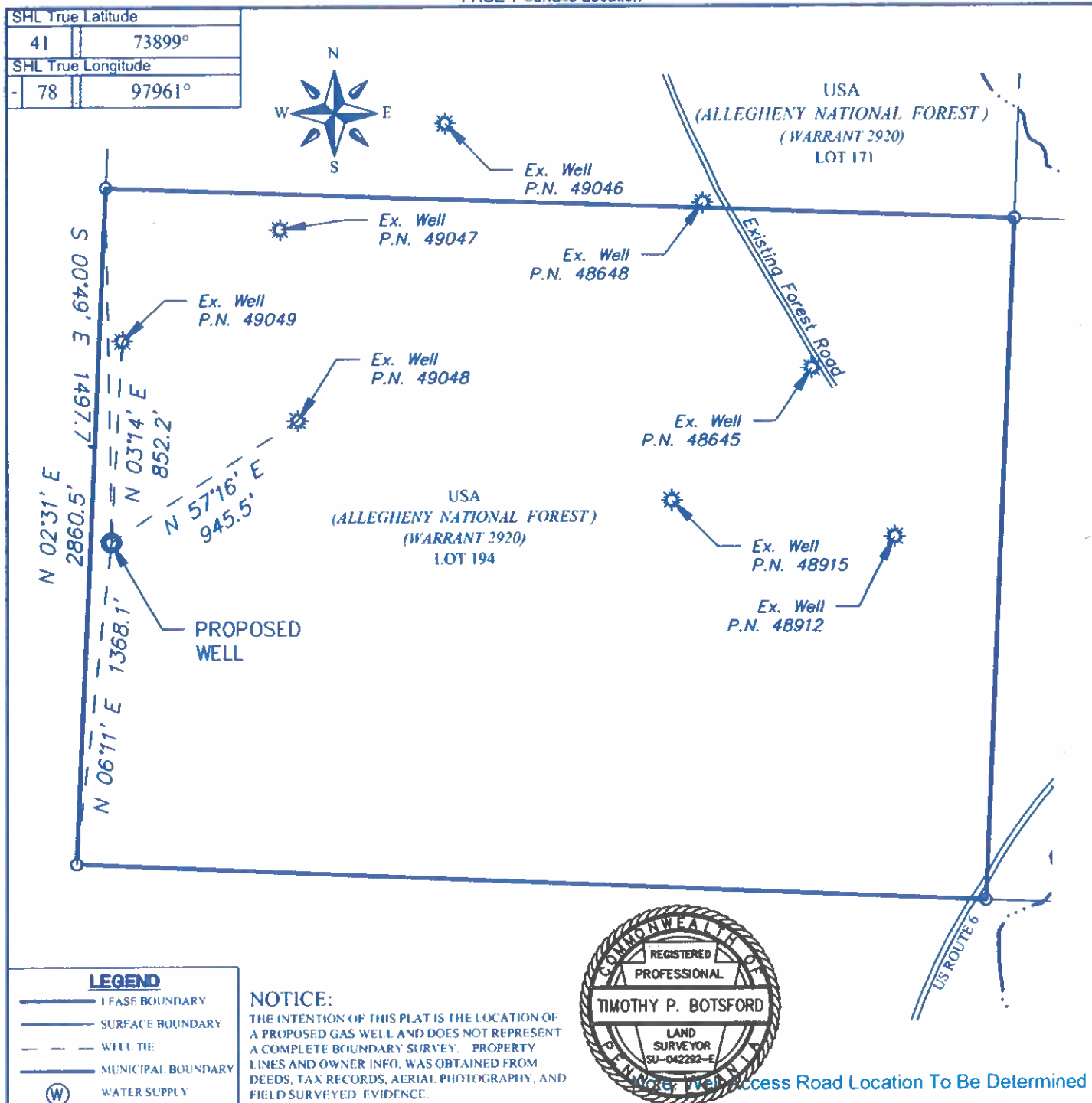

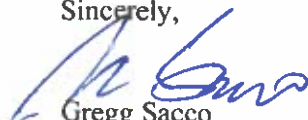

The Proposed Oil Well will be the drilling of a new well located as represented on the well location plat which is also provided with this narrative. The anticipated total depth of the proposed well will be 2000' and will target the Cooper sand. The total disturbed acreage for the project will not exceed five acres.

This project will consist of the construction of a 75' x 100' well pad around the well location with appropriate access roads from existing roads. In addition, a 20,000 gallon freshwater inventory tank will be constructed on well pad for use in fracking the proposed well. Prior to construction all necessary BMP's will be installed and will remain until the site is reseeded. All remaining disturbed areas will be prepared for vegetative stabilization. All disturbed areas must be covered with uniform 70% perennial re-vegetation, the straw bale bio filter fence and any other temporary BMP's will be removed. Any excess soils and waste materials will be disposed of in an environmentally sound manner.

Current site condition consists of cleared ground. No wetlands exist within the proposed project boundary and no wetlands will be disturbed during construction of the project.

Any recommendations from regulatory agencies (PGC, PA DCNR, PFBC, USFWS, etc.) will be adhered to in the best practical manner.

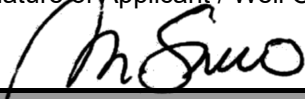

Section B: Alternative Waste Disposal Practices Explanation

We are requesting approval to place uncontaminated drill cuttings and top-hole water into the unlined pit via the drill rig cuttings removal pipeline. Any water and/or additives yielded during drilling will be segregated and handled according to acceptable procedures.

Prior to frac a 20 mil pit liner will be placed in the pit, on top of the drill cuttings, to contain frac fluids.

Drill cuttings will be contained in the pit, the location will be graded, seeded and mulched after the well is completed.

Historical records indicate that shallowest ground water would be encountered at depths below 90-110 feet.

The proposed well location is approx. 1600' from a tributary to Deer Lick Run.

There are no water supplies within 1000' and there are no streams or wetlands within 600'.

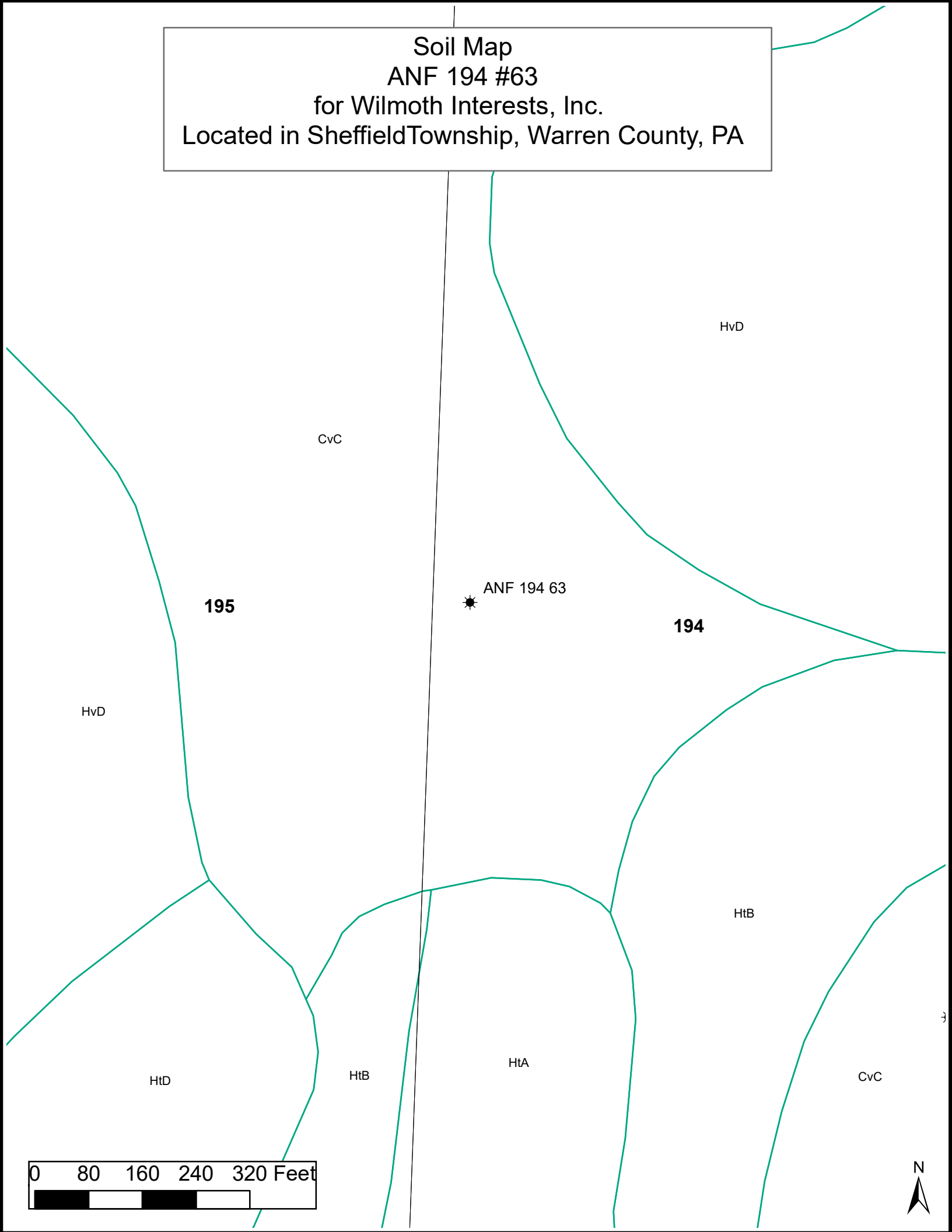

Special Conditions:

AWM1

The Operator shall comply with the following:

1. Notify their local Oil and Gas Inspector three days prior to dusting.
2. Drill cuttings shall remain on the well site they are generated and shall not be dispersed off-site via air, surface water, or groundwater.
3. All isolation distances identified in 25 Pa. Code § §78.60 – 78.63 are applicable.
4. Drill cuttings may be disposed of in a pit, without contact with season high ground water.
5. Upon well completion, the pit shall be backfilled and graded to promote runoff. The stability of the backfilled pit shall be compatible with surrounding area and the pit area shall be revegetated to stabilize surface soil.
6. Land application may only occur on the cleared well pad area and the drill cuttings shall be spread and incorporated to a depth of at least 6 inches and revegetated to stabilize surface soil.
7. No land application shall occur if the ground is frozen or saturated.
